EXPLANATORY NOTE

Pursuant to General Instruction E to Form S-8 under the Securities Act of 1933, as amended, this Registration Statement is filed by Sonnet BioTherapeutics Holdings, Inc. (the "Company") for the purpose of registering additional shares of the Company's common stock, par value \$0.0001 per share (the "Common Stock") under the Company's 2020 Omnibus Equity Incentive Plan (the "2020 Plan"). The number of shares of Common Stock available for issuance under the 2020 Plan is subject to an automatic annual increase on January 1 of each year beginning in 2021 and ending on (and including) January 1, 2030, equal to four percent (4%) of the total number of shares of Common Stock outstanding on December 31st of the preceding calendar year, or a lesser number of shares of Common Stock available for issuance under the 2020 Plan as a result of the Evergreen Provision"). This Registration Statement registers an aggregate of 318,561 additional shares of Common Stock available for issuance under the 2020 Plan as a result of the Evergreen Provision.
